1 Chapter 210 – Vehicles and Traffic, Article 12.3.G(4): Perkins Cove Annex Parking

Discussion of the ordinance reviewed by the Select Board on March 3, 2026, including follow-up questions from that meeting.

- *Is there a two-hour limit for business?*
- *What is the end time?*
- *Is anything open in the evening?*
- *What amounts do people pay?*
- *Does the Town get revenue from when visitors park in these spots?*
- *If a space is empty at 4:00 pm, can I park, as a resident? Does this change prohibit that?*
- *Can residents park after 9:00 pm?*
- *Do you want to take away opportunities for residents and give them to non-resident commercial people? Because we have added more commercial boats?*
- *How many spots?*
- *Are residents allowed to park if they live in an apartment?*
- *Overnight residents?*
- *Genesis behind the change? Fisherman don't feel they have a place to park?*
- *Was there repretation from the business community or the resident community on the harbor community?*
- *Is there a stopgap solution we can come up with for this year?*
- *If a resident has a boat do they get priority to park?*

- *If I get a rowboat where can I put it?*
- *Has there ever been a traffic study in the Cove? Is this a time to do it?*
- *Permit only is permit only. What is a permit?*

§ 210-12.3. General restrictions.

G. Perkins Cove special regulations.

(4) Perkins Cove annex parking. This is defined as the six spaces and one handicap space east of the Harbormaster's office and shall be by Commercial Boat/Perkins Cove Shop Owner Permit Parking Only ~~the six spaces east of the drawbridge along the Boardwalk and the three spaces in front of the shops.~~ These spaces are available to the general public with restrictions as indicated by signage (i.e., loading zone), and with a two-hour limit. **[Amended 4-18-2006]**
